#### 2. DISPOSAL OF SURPLUS FY 2021

It was resolved that:

- I) Interest on Members' deposits for the financial year ending December 2021 to be paid to members at the rate of 7% on weighted average basis less withholding tax
- II) Dividends on share capital for the financial year ending December 2021 to be paid at 8%.

## 3. MINIMUM DEPOSIT CONTRIBUTION

It was resolved that the minimum monthly deposit contribution for members be increased from Ksh. 2,000 to Ksh. 3,000 with effect from June 2022. However, for affiliate company members retained at shs. 2,000

### 4. MICRO CREDIT PRODUCTS AND SERVICES

It was resolved that the Society to diversify its membership by introducing Micro Credit products and services for members in business. This is to target new markets and boost growth of membership which has in the recent past been negatively impacted by the Covid I9 pandemic.
